There will be a Pre-Bid Meeting held on **November 27, 2017 @ 3:00 p.m. at the Woodhaven Brownstown Central Office Administration 24821 Hall Road, Woodhaven, MI 48183**. The meeting **is not** mandatory, but is highly recommended. Attendees desiring to visit the buildings will have the opportunity to do so after the meeting.

A **sworn and notarized statement disclosing any familial relationship** existing between the bidder and any member of the school board, school superintendent, or district executive, as defined in Michigan Public Act No. 232 of 2004, must accompany each bid. The Board of Education will not accept a bid that does not include this statement. This statement is provided on the Proposal Execution Form, Section 004205, of the Bidding Requirements and General Conditions Manual for the project.

Each bid shall be accompanied by a certified check, cashier's check, money order or bid bond made payable to Woodhaven Brownstown School District in an amount not less than five percent (5%) of the base bid as a bid guarantee that if the proposal is accepted, the bidder will execute the contract and file the required bonds within ten (10) days after notice of contract award.

If awarded a contract, the successful bidder may be required to furnish a Performance Bond and Labor and Material Payment Bond in the amount of 100% of the contract price.

Withdrawal of any bid is prohibited for a period of ninety (90) days after the actual date of the opening thereof.

Woodhaven Brownstown School District reserves the right to reject any or all bids received, either in whole or in part, to reject a bid not accompanied by the required bid guarantee, or by other data required by the bid documents and Michigan law or to reject a bid which is in any way non-compliant with the bid requirements.
